# C20 Think Tank Includes Recommendations by JEET on Philanthropy and Educational

The Civil 20 - Chaupal Meet held in Mumbai on March 18th, 2023, brought together various stakeholders to discuss challenges and recommendations for promoting philanthropy and educational equity. The outcomes of the meet will be summarized and shared with G20 Leaders in Delhi. One of the key highlights of the meet was the recommendations proposed by RKSS - JEET, which were accepted by the think tank and will be forwarded to the G20 group in Delhi. The recommendations aim to address the following challenges:

**Challenge 1**: Simplifying Bureaucratic Formalities - The increasing formalities, documentation, and bureaucratic regulations are limiting the interest of people in philanthropy.

Challenge 2: Lack of Synergy Amongst NGOs - Various organizations working towards the same social cause are not aware of each other's activities, leading to repetitive efforts and lack of unity.

**Challenge 3:** Educational inequity - Around 200 million disadvantaged and disabled school children in India are deprived of their right to quality education.

In response to these challenges, the following solutions were proposed: *Solution 1:* Reducing Paperwork - Registrations and related paperwork should be minimized to encourage people to run social organizations. *Solution 2:* Building Social Platforms - Social platforms should be created where different NGOs can interact, discuss problems they face at different stages, and resolve them together. United NGOs can save on overheads and legal costs involved therein.

**Solution 3:** Education and Skill Development - Providing access to free online courses, tutorials, and other learning materials, hosting workshops and training sessions, working with local non-profits and community centers, and connecting individuals with mentors for guidance, advice, and support to develop new skills.

Additionally, Civil 20 - Chaupal Meet discussed several long-term action plans to promote educational equity at the meet, indicating a commitment to building a more equitable and philanthropic society. The solutions proposed aim to reduce bureaucratic formalities, promote synergy amongst NGOs, and provide education and skill development opportunities for all. The acceptance of these recommendations by the think tank and their forwarding to the G20 group in Delhi is a positive step towards creating a more conducive environment for philanthropy and promoting educational equity.

# New Tax Regime and Its Potential Impact on Charitable Giving

The new budget announcement of increased tax exemptions may impact retail charitable giving as taxpayers may opt for the new tax regime rather than the previous tax regime that provides charitable contribution deductions under section 80G of the Income Tax Act. Concerns have been raised that the new default tax regime may discourage taxpayers from making charitable contributions. However, the impact of the new tax regime on charity donations is unknown, and educational groups may need to adjust their strategy to ensure continued donations. Encouraging people to contribute to the social impact rather than the financial benefits they receive may be one way to mitigate the impact of the new tax regime on charity giving.
